## Helpful Resources and Information for the Oppressed

The term "abuse" is used very broadly in our society. While the term is not used frequently in the Bible, the Bible does describe and condemn "oppression" and "affliction". A good definition of domestic oppression or "abuse" is: "A pattern of physical or verbal behavior that is used by one spouse to gain or maintain power and control over (the oppression and the affliction) another spouse and (frequently) to prevent the other spouse from seeking help or protection. Such oppression can include physical violence (including sexual), economic, or threats of actions that influence another person. This includes any behaviors that intimidate, manipulate, humiliate, isolate or restrain (physically and relationally), frighten, terrorize, coerce, threaten, blame, hurt, or injure someone."

If you are a victim of domestic oppression/abuse, please know that <u>your safety is of first importance</u>. This document is provided to help you to reach out for the help you need. After attention has been given to your physical safety, we strongly encourage you to seek biblical counseling through the Hope Center of Christian Family Chapel. This hotline provides free legal advice and referrals to victims of domestic, dating, and sexual violence and stalking regarding injunctions for protection, family law, housing, immigration, and other civil legal matters. Non-English-speaking hotline callers have access to language interpreters.

## INJUNCTION / RESTRAINING ORDERS

This is a Court order that tells one person to stay away from and not contact another person by phone, email, letter, in person, or through text mgs. It can tell someone to stay away from home, car, work, and any other places the court feels are necessary.

These are done in civil court, not criminal court. The person requesting the injunction is the one who keeps the case going. Before final judgment is given, the person asking for the injunction can ask the court to drop or stop the order, filing a form called a Voluntary Dismissal. The civil/family clerk's office has these forms.

After a final judgment is entered, the person requesting the injunction can ask the court to drop or change the injunction, and a hearing will then be scheduled about the dismissal or change to the order. An injunction does not ask the court to put the other person in jail, but if the other person violates it, he or she may be arrested.

The clerk cannot give you legal advice. You can print the forms from the internet too, but you still must file them in the clerk's office once they're completed or have them notarized and delivered to the clerk's office. Forms are available online at: www.flcourts.org under family law forms. Fee: There is no cost for filing for an injunction for protection or for any motions to change or dismiss an injunction.
